BCRC 12-232, General Provisions

The applicant is requesting a deviation of the 25' property line setback. This request is in accord with this section.

BCRC 12-233, Application, contents

In accordance with BCRC 12-233, the applicant submitted all the required documents and the application was deemed complete on August 25, 2025.

BCRC 12-238, Administrative Variances

In accordance with BCRC 12-238, the applicant is seeking a 30% variance to the required property line setback.

BCRC 12-234, Variance, standards for review of applications

- (a) Conditions apply to the property that do not apply generally to other properties in the same zone or vicinity, which conditions are a result of lot size, shape, topography, or other circumstances over which the applicant has no control.**

Applicant: "This site has excessively steep slopes on all sides of the only desirable homesite on the property. This home has been redesigned several times to minimize its width east to west, while maintaining the view the homesite provides. As the home moves South East away from the property line, the house quickly falls off the steep slope. Any further movement in this direction incurs unmanageable costs in soil and structural engineering as well as a greater stormwater containment issue. For this reason we are petitioning this variance of 7.5' from standard to allow the construction of this home without exorbitant cost and erosion risk to the land south of the property. We appreciate your consideration on this request."

Staff: According to GIS LiDAR data, the subject property is primarily made up of slopes exceeding 30%. This can present notable challenges when determining the position of the single-family dwelling. The applicants are proposing to locate the home on top of the steep slope as much as possible which is pushing the home closer towards the property line setback.

The subject parcel does not contain any wetlands, Special Flood Hazard Zones, or frontage on any mapped water body. There do not appear to be any other environmental features that would necessitate a variance.

- (b) Special conditions and circumstances do not result from the actions of the applicant.**

Applicant: "As discussed above, this Parcel has mountainous terrain limiting the buildable and reasonably accessible areas on the lot. The property owner has made attempts to purchase a small strip of the unoccupied neighboring land, but has not been successful in doing so."

Staff: The applicant acquired the subject property on January 2, 2024, via Gift Deed, Instrument #1029208. There is no evidence that the applicant has changed the parcels size, shape, or topography in a way that would cause a variance to be required. The steep conditions on the property are outside the applicants control.

- (c) The granting of the variance is not in conflict with the public interest in that it will not be detrimental to the public health, safety, or welfare, or materially injurious to properties or improvements in the vicinity of the subject parcel or lot.**

Applicant: "The variance will not conflict with public interest as the neighboring properties are unoccupied and/owned within the family. The structure is a single-family residence with only seasonal occupancy, preventing a nuisance to any potential future land use of the neighboring properties."

Staff: No comments were received from the public or any agency indicating this variance would be detrimental to the public health, safety, or welfare, or be materially injurious to properties or improvements in the vicinity of this subject parcel.

BCRC 12-7.2, et seq., Grading/erosion/stormwater management

Grading, stormwater management and erosion control concerns were addressed during the Building Location Permit process, File #BLP2025-0451.

NOTE: Any determination made by the Planning Director in the administration of the provisions of this title may be appealed to the Board by paying the required fee and notifying the Planning Director in writing of the intent to appeal within ten (10) working days from the date of the determination. Within ten (10) working of receipt of an appeal,

the Planning Director shall schedule a meeting with the Board to hear the appeal and shall provide written notice to the appellant of the time and place of the meeting. The Planning Director and appellant shall be provided an opportunity to present the relevant issues to the Board at that meeting. The appellant bears the burden of proof and may be responsible for costs incurred for producing such proof, including engineering or surveying documents for other evidence. The Board's decision shall be final, and further recourse of the appellant shall be as provided by Idaho Code. If no appeal to the Board is filed, the Planning Director's decision shall be deemed final. (BCRC 12-261)

Following any final decision concerning a site-specific land use request, the applicant has a right to request a regulatory taking analysis pursuant to Section 67-8003, Idaho Code (Idaho Code §67-6535(3)).

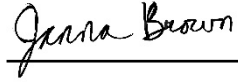
