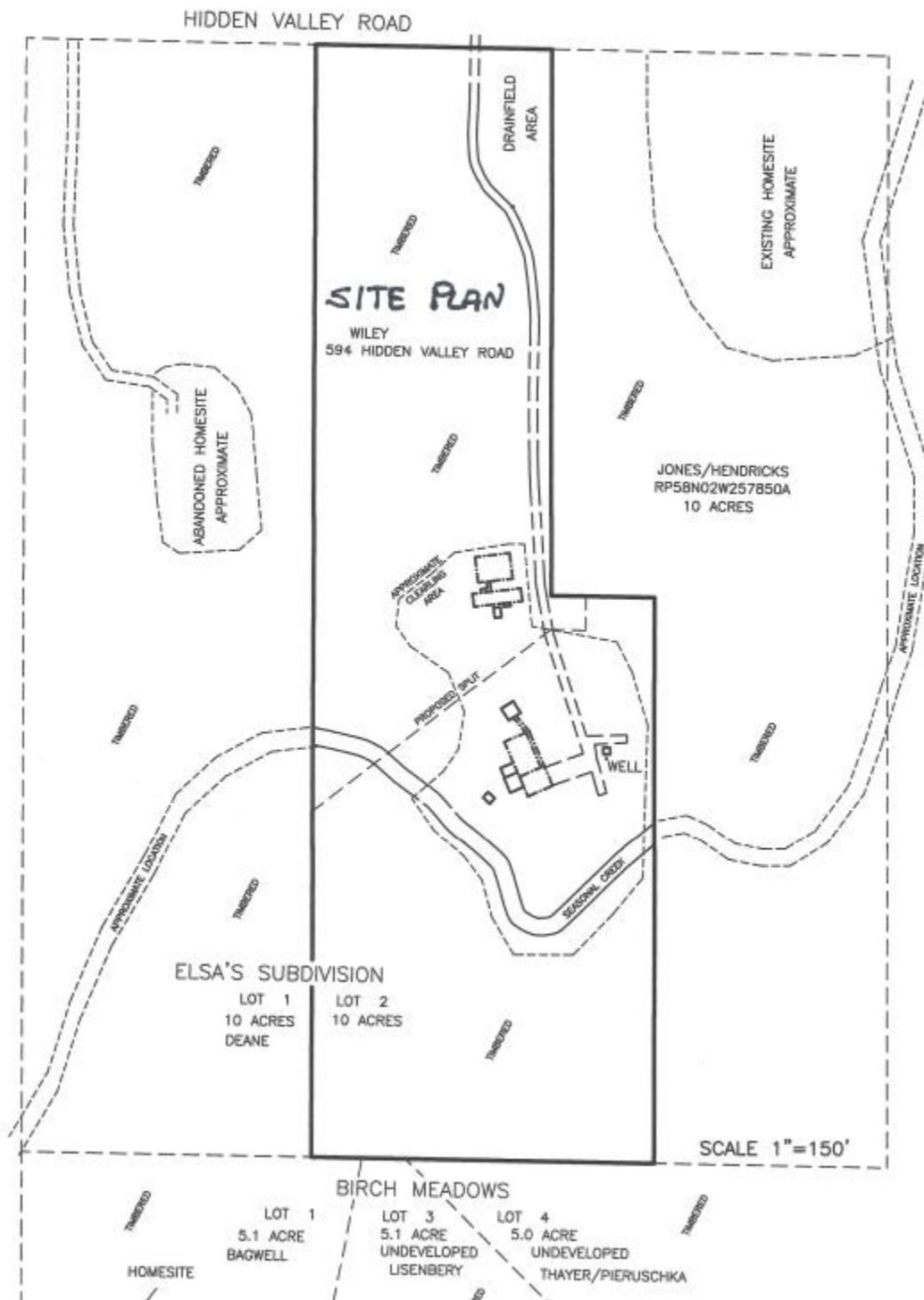

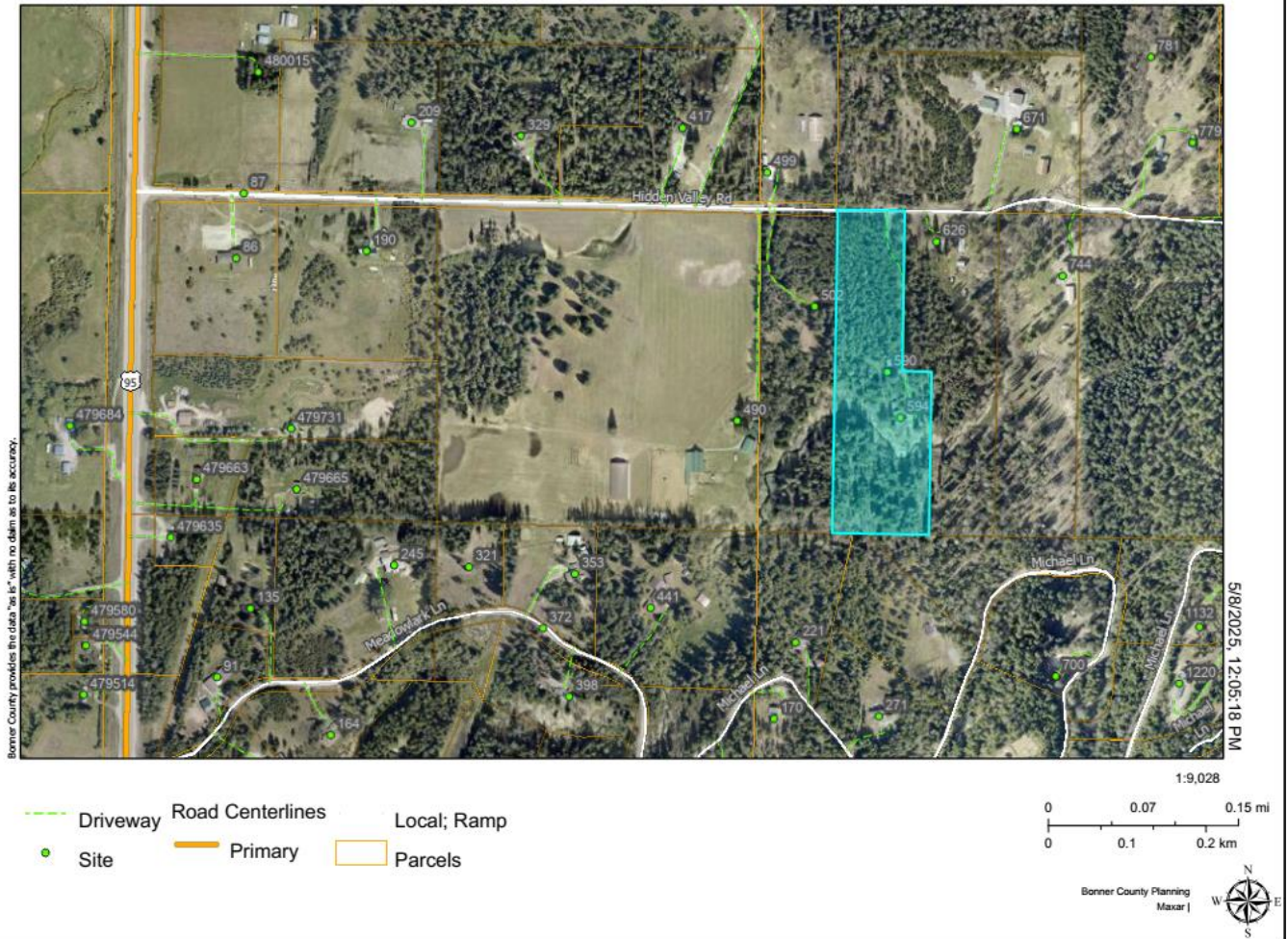

Project summary:

The applicant is requesting a Zone Change from Rural 10 to Rural 5. The 10-acre property is zoned Rural 10. The project site is located off Hidden Valley Road in Section 25, Township 58 North, Range 2 West, Boise-Meridian. The comprehensive plan designation is Rural Residential (5-10 AC).

Applicable Laws:

Background:

A. Site data:

- Use: Residential
- Platted – Elsa’s Subdivision Lot 2
- Size: 10-acres
- Zone: Rural-10
- Land Use: Transition

B. Access:

- The parcel is accessed off Hidden Valley Road a Bonner County owned and maintained right-of-way.

C. Environmental factors:

G. Public Notice & Comments

As of the date of this Staff Report, the Planning Department has received public comments.

Standards Review and Staff Analysis:

- **12-111: PURPOSE**

The zoning regulations and districts for the unincorporated areas of Bonner County, as herein established, have been made in accordance with a comprehensive plan and Idaho Code for the purpose of promoting the health, safety and general welfare of the people of Bonner County.

- **12-215:** Applications for Zone Changes and Comprehensive Plan Map Amendments, Contents

Staff: The application was considered complete and routed to agencies accordingly.

- **12-216:** Evaluation of Amendment Proposals
 - Staff and the Governing Bodies shall review the particular facts and circumstances of each proposal submitted and shall determine whether there is adequate evidence that the proposal is not in conflict with the policies of the comprehensive plan. (Ord. 501, 11-18-2008)

Comprehensive Plan Analysis:

Property Rights

Policies:

1. Bonner County should follow the attorney general's checklist, proscribed at Idaho Code §67-8003 and provided in the "Property Rights" component of the county's comprehensive plan, for all land use decisions.
2. For all land use decisions, findings of fact and conclusions of law should be adopted that reflect the justifications for exactions, conditions and restrictions and should confirm that a taking of private property has not occurred.
3. The property rights of the applicant, adjoining and nearby landowners and future generations should be considered, as well as the short-term and long-term consequences of decisions.
4. Bonner County should review all rezoning requests (down-zoning and up-zoning) pursuant to the Idaho State Code, Title 67, Chapter 65 – Local Land Use Planning Act. The approval of conditional rezoning or denial of a request for rezoning may be subject to the regulatory taking analysis provided for by Idaho Code Section 67-8003.

Staff: The application was routed to neighbors 300' from the property line, informing neighbors of the proposed zone change. As of the date of this staff report, Bonner County has received public comments. This proposal has been reviewed for compliance with Bonner County Revised Code and a reasoned statement will be adopted with the decision of this project. At the time of initial application this project was located within the Area of Impact for Ponderay; however, the Area of Impact for Ponderay was amended while the application was being considered, and the subject property is no longer within the AOI. This proposal does not appear to be in conflict with the policies of this component.

Population

Policies:

1. Population projections should be analyzed regularly to determine if changes need to be made to the Comprehensive Plan goals, objectives and policies and/or the Zoning

Ordinance to ensure that the public and community needs are being met through land use decisions.

2. Population forecasts and census data should be used to evaluate housing and school needs, and impacts to the transportation system and other county services.

3. Bonner County should cooperate with its incorporated cities and neighboring counties to address growth challenges within the ACI areas and coordinate planning efforts whenever possible.

Staff: Bonner County, according to 2023 population estimates census data, has seen a 11.55% increase in population since the 2020 census was performed; increasing from 47,103 to an estimated 52,547. With the increase in the population, there is upward pressure on housing needs in Bonner County, both in the unincorporated portion of the County, and in the incorporated cities. This proposal is within the Area of City Impact of Ponderay; however, they did not provide a comment on this proposal. This proposal does not appear to be in conflict with the policies of this component.

School Facilities & Transportation

Policies:

1. Current data regarding school capacity and transportation issues as provided by the School Districts will be included in the assessment of all land use proposals.

2. Bonner County should examine the impacts of land use proposals to the school system and should seek mitigation from developers such as providing facilities, safety features, fees or other measures as permitted by Idaho Code, to address the impact of the proposals.

Staff: The Lake Pend Oreille School District #84 and Lake Pend Oreille School Transportation that serves the property were notified of the proposed zone change. Lake Pend Oreille School District did not comment as to how an increase in density and development would or would not adversely impact the district's ability to provide adequate school services (and facilities) for new and existing students. The Transportation department did not provide a comment. This project does not appear to conflict with this component.

Economic Development

Policies:

1. Small scale cottage businesses and home occupations should be allowed in all areas of the county. Reasonable conditions on such uses should be set to minimize adverse impacts to the neighborhood based on factors including, but not limited to, hours of operation and traffic volume generated by the business.

2. Develop land use regulations to allow Bonner County's agricultural heritage to be maintained by enabling local food production, distribution, congregation, and retail sales. Examples include community gardens, school gardens, farm related education programs, farmers or public markets, and other small-scale, collaborative initiatives.

3. Develop standards for commercial and industrial development that are appropriate for the surrounding community, including: appropriate site sizes, use types, buffering and design standards that encourage both attractive and efficient function, while protecting the environment.

4. Review and update land use regulations for employee housing to support the goal of enabling this use in proximity to commercial, industrial and agricultural uses.

Staff: This proposal does not appear to be in conflict with the policies of the economic development component.

Land Use

Policies:

1. Commercial and industrial uses, in areas identified in the Comprehensive plan suitable for such development, should be unconditionally permitted. Evaluation of suitability should be based on availability of urban services, adequate access to hard surfaced publicly maintained roads and other factors that may impact the surrounding community.

2. Commercial and industrial uses may be conditionally permitted in areas not identified for such uses in the Comprehensive Plan if a critical review of the proposed use determines that with appropriate conditions the use will not adversely impact the surrounding area.

Staff: The proposed zone change from Rural-10 to Rural-5 does not appear to conflict with the policies of this component. The Rural zones do allow for some commercial and industrial uses, either permitted for conditionally permitted, per BCRC 12-3.3. Per the application, the intent of this zone change is to later divide the property in half for residential purposes.

Natural Resources

Policies:

1. Watershed standards should be employed in land use codes to protect water quality.

2. Best management practices for waterway setbacks should be instituted to reduce erosion and sedimentation into waterways.

3. Development standards should be designed to encourage clustered development resulting in the preservation of open space and wildlife habitat.

4. Bonner County should recognize its critical wildlife habitat and create development standards to protect these areas and mitigate development impacts to these habitats.

5. Protect water quality by creating standards for development in close proximity to shorelines.

6. Productive farmland, timberland and mining lands should be identified and protected from adverse effects of adjoining developments.

Staff: Impacts to natural resources were not identified by any agency. Furthermore, Bonner County Revised Code has regulations to protect natural resources. This project does not appear to be in conflict with the policies of this component.

Hazardous Areas

Policies:

1. Flood mitigation standards should be adopted that meet or exceed the National Flood Insurance Program minimum requirements.
2. Residential, commercial or industrial development within the floodway should be discouraged.
3. Fill within the floodplain should be discouraged.
4. The county's wildland fire, urban/wildland interface policies and plans should be integrated into development standards.
5. Excessive slopes should be identified and development discouraged by providing lower densities within these areas.
6. Multiple points of ingress/egress should be considered for large developments
7. Development should be avoided in avalanche zones.

Staff: The subject property is not located in a mapped floodplain. The parcel does contain any mapped slopes of over 30% grade. Furthermore, the property is afforded emergency services. The risk of avalanches in this area appear to be minimal. The proposal does not appear to be in conflict with these policies.

Public Services, Facilities & Utilities

Policies:

1. Encourage high-density development to take place within the boundaries of existing sewer and water areas.
2. Bonner County should seek comment from existing service providers on their ability to serve future developments without adversely impacting the ability of the utility providers to serve current users.
3. Bonner County should provide adequate facilities for responsible disposal of solid waste to protect the health and welfare of the public as well as the County's natural resources.

Staff: Current services on this property include individual well, individual septic, Northern Lights, Inc., Bonner County EMS & Sheriff, and North Side Fire District. All the above-mentioned agencies were notified of this file and did not respond as to how this zone change could affect their ability to provide services. This proposal does not appear to be in conflict with the policies of this component.

Transportation

Policies:

1. A long-term transportation system plan should be developed and regularly updated to ensure reasonable levels of service can be maintained in the future, and that needs for future road extensions or transportation corridors are identified as early as possible.
2. Development in areas that are not served by county standard roads or where transportation is inadequate should be discouraged.
3. Bike and pedestrian trails should be considered in development proposals to connect the communities with existing and planned bike and walking paths wherever possible.

Staff: This proposal does not appear to be in conflict with the policies of this component.

Recreation

Policies:

1. Bonner County is encouraged to develop a waterways and park access program to preserve and develop access to public recreational lands and waterways. The program should include retaining access parcels that may be acquired from tax sales or private donations.
2. A plan for a system of green belts and pathways (bike and pedestrian) should be considered as areas develop, so that a connected system can be developed and preserved.
3. Under no circumstances, will Bonner County require access easements on private property as a condition of development. This policy does not preclude providing voluntary incentives to developers in return for access easements.

Staff: Recreational opportunities that are available in Bonner County are anticipated to remain the same with this zone change. This proposal does not appear to be in conflict with the policies of this component.

Special Areas or Sites

Policies:

1. A generalized map of the known pre-historic and historic sites should be developed so that future developments are aware of special areas of concern and are connected

with the historical society and Native American tribes for appropriate preservation and protection.

2. Bonner County should implement road side development standards for recognized scenic byways to protect the view sheds.

3. Special areas should be recognized and addressed when development is proposed in these areas.

Staff: This proposal does not appear to be in conflict with the policies of this component.

Housing

Policies:

1. Encourage development of a variety of housing options including mobile home parks, tiny home communities and recreational vehicle parks located in areas that are compatible with their density.

2. Work with municipalities and private parties to find solutions for all types of housing projects and developments.

3. Clustering of housing in developments to save on infrastructure and transportation costs should be encouraged through mechanisms such as density bonuses.

4. Bonner County recognizes opportunities should be made for assisted living and group shelters.

5. Enable workforce housing in direct proximity to agricultural, commercial and industrial uses.

Staff: This proposed rezone may result in more opportunities for a variety of housing options in Bonner County; therefore, it does not appear to be in conflict with the policies of this component.

Community Design

Policies:

1. To promote and preserve the natural features and rural atmosphere of the community, the county should enact development standards that address development within scenic byways and design standards that account for waterfront setbacks, wildlife corridors, commercial and industrial landscaping, requirements for reduced lighting, cluster development, rural rather than urban setback standards and other design objectives aimed at preserving the rural, natural character of the community.

2. Allow unique and flexible design standards such that new development within older neighborhoods and historic settlements is compatible with those unique neighborhoods.

3. Allow particularized design standards to address waterfront and mountaintop developments which may differ from standard design objectives.

Staff: This proposal does not appear to be in conflict with the policies of this component.

Agriculture:

Policies:

1. Residential uses should continue being permitted in Agricultural zoning districts.
2. Protect agricultural uses and activities from land use conflicts or interference created by residential, commercial or industrial development.
3. Land use regulations should support home occupations, cottage industries and farm-based family businesses on agricultural parcels. Examples include farm stands and other agri-business pursuits.
4. Bonner County acknowledges the provisions of Idaho State's Right to Farm Act. Those shall be considered in the land use decisions.

Staff: This proposal does not appear to be in conflict with the policies of this component as farming and agricultural pursuits are encouraged in the Rural Zoning Districts.

- **12-263: Reconsideration**

- A. Reconsideration: Every applicant or affected person seeking judicial review of the Board's final decision must first file with the Board a motion for reconsideration of the Board's decision, specifying deficiencies in the decision within fourteen (14) days of the date of the decision, along with the applicable fee. A failure to seek reconsideration is also a failure to exhaust administrative remedies.

Staff: The Board decision was rendered on September 3, 2025. The reconsideration request was received and fees paid for on September 8, 2025.

- B. Initial Decision: The Board may consider the reconsideration motion as scheduled on an open business meeting agenda and determine whether to grant or deny the request. If the Board grants reconsideration in whole or in part, a hearing before the Board will be scheduled to address the specific deficiencies identified by the applicant or affected person and to allow interested persons to have an opportunity to be heard. If the Board denies the request for reconsideration, it shall promptly notify the parties in writing.

Staff: During an executive session held by the Board of County Commissioners on September 23, 2025, the Board agreed to reconsider their decision and hear the file in its entirety.

- C. Public Notice On Hearing: Notice of the public hearing on the reconsideration, identifying the specific deficiencies alleged in the reconsideration request, will be provided as follows, including:
 - 1. Notice To Agencies And Political Subdivisions: At least fifteen (15) days prior to the public hearing, the Director shall send notice to all political subdivisions providing services with the planning jurisdiction, including school districts and the manager or person in charge of the local public airport.
 - 2. Legal Notice: At least fifteen (15) days prior to the public hearing, the Director shall publish a notice of the time and place in the official newspaper or paper of general circulation in the County.
 - 3. Radius Notice: Will be provided in the same manner as originally provided on the application.

Staff: This reconsideration request was noticed to the public and public agencies on October 2, 2025.

- D. Decision: Following the hearing on the reconsideration, the Board may affirm, reverse or modify its prior decision and shall provide a written decision to the applicant and the affected person(s) within sixty (60) days of receipt of the request for reconsideration. If the Board fails to timely decide, the original decision of the Board will stand. (Ord. 573, 10-25-2017)

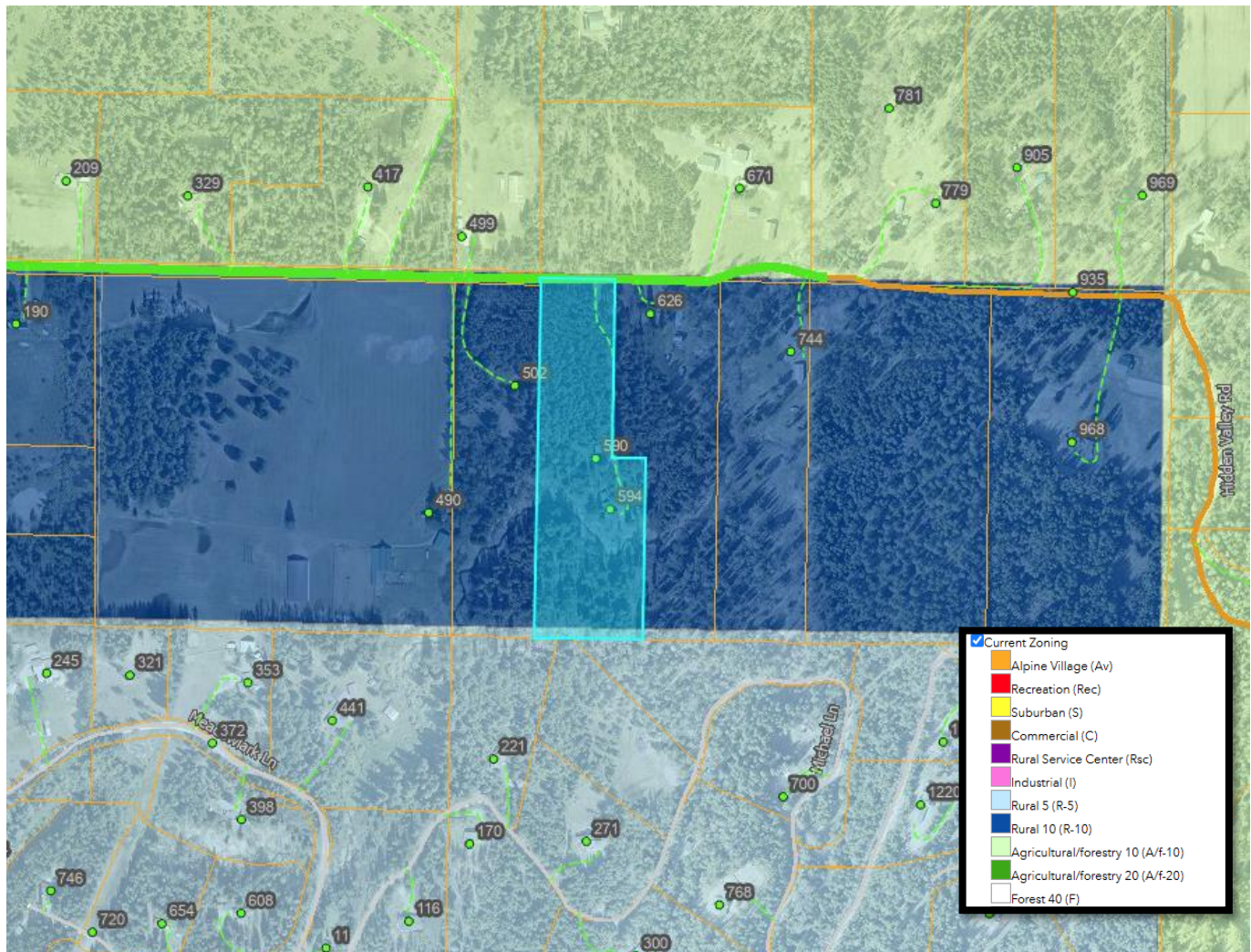
Staff: The hearing is scheduled for October 29, 2025.

- **12-320.1: Zoning Districts and Map Designation, Purpose:**
 - The purpose statements for each zone and map designation set forth in the following sections shall be used to guide the application of the zones and designations to all lands in unincorporated Bonner County. The purpose statements also shall guide interpretation and application of land use regulations within the zones and designations, and any changes to the range of permitted uses within each zone through amendments to this title. (Ord. 501, 11-18-2008)
- **12-320.2: Zoning Districts and Map Designations Established:**
 - In accordance with the provisions of Idaho Code and the objectives set forth in this code, all land in the unincorporated areas of Bonner County is hereby classified according to the following zoning designations and zoning map symbols, which shall be applied as shown on the official zoning district map.

Existing Comprehensive Plan Designation:

Rural Residential: The Rural Residential area provides for residential development in areas where urban services are not available and slopes may vary up to 30%. These areas include hazard areas and critical wildlife habitats, where lower densities reduce potential impacts to resources and exposures to loss of property or lives. Small-scale agricultural uses and residential development are permitted.

Existing Zoning:



BCRC 12-323: RURAL DISTRICT (B-1, Rural 10):

A. The rural district is established to allow low density residential uses that are compatible with rural pursuits. The purpose can be accomplished by:

1. Limiting residential densities and permitted uses to those that are compatible with rural character and nearby resource production districts and sites and can be adequately supported by rural service levels.
2. Allowing small scale farming and forestry activities, and tourism and recreation uses that can be supported by rural service levels and are compatible with rural character.
3. Encouraging conservation development configurations that create permanent open space or farming areas, protect sensitive environmental features, reduce infrastructure costs and/or enhance recreational opportunities.

B. Use of this zone is appropriate in areas designated by the comprehensive plan as follows:

1. R-10 in areas designated as rural residential in the comprehensive plan that meet one or more of the following criteria:

- a. Characterized by slopes that are steeper than thirty percent (30%).
- b. Located within critical wildlife habitat as identified by federal, state or local agencies.
- c. Contain prime agricultural soils.
- d. Served by a network of public and/or private roadways that generally do not meet applicable roadway standards set forth in title 2 (public roads) of this code or appendix A (private roads) of this title or are absent.
- e. Within the floodway.
- f. Contain limited access to public services.

Proposed Zoning:

BCRC 12-323 RURAL DISTRICT (B-2, RURAL-5):

B. Use of this zone is appropriate in areas designated by the comprehensive plan as follows:

2. R-5 in areas designated rural residential in the comprehensive plan that are already developed at or near the one dwelling unit per five (5) acre density and/or do not meet the criteria for R-10 above.

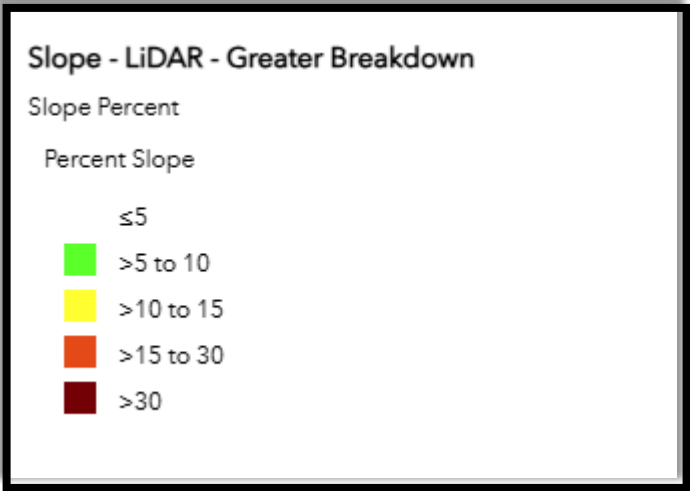
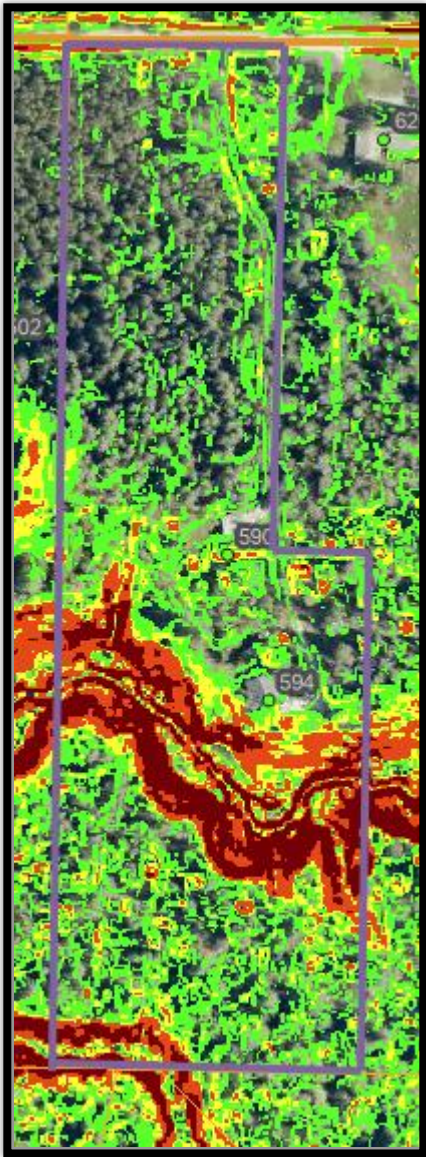

Rural 10:

Characterized by Slopes Steeper Than 30%:

The subject lot does not appear to be characterized by slopes steeper than 30% (as shown in the GIS LiDAR image). The slopes on the lot appear to be following the stream that runs east/west through the southern portion of the property. According to the land use portion of the comprehensive plan for density ranges, properties that are level to moderately slopes are appropriately sized to be 5-10 acres.

Per the applicant's reconsideration request , they contend the property is not characterized by slopes steeper than 30%. **See Reconsideration Request.**



Located Within Critical Wildlife Habitat:

No critical wildlife area was determined by any public agency. Additionally, GIS data does not show the property is located within any critical wildlife area.

Contains Prime Agricultural Soils:



The parcel contains three types of soil: Pend Oreille-Rock outcrop complex, 5 to 45 percent slopes (purple, 37), Mission silt loam, 2 to 12 percent slopes (orange, 32), and Selle-Mission complex, 0 to 12 percent slopes (yellow, 50). According to the Natural Resources component of the Bonner County Comprehensive Plan, Pend Oreille-Rock outcrop complex, 5 to 45 percent slopes is considered "Not Prime Farmland"; this soil makes up approximately 1-acre of the subject lot. Not Prime Farmland is considered as: "All other soil types not classified as Prime Farmland or Farmland of Statewide Importance are classified as Not-Prime Farmland", per the Natural Resources component of the Bonner County Comprehensive Plan.

Approximately 7-acres of the subject property is made up of Mission silt loam, 2 to 12 percent slopes (orange) which is classified as "Farmland of statewide importance, if drained". This is not considered prime farmland. Finally, approximately 2-acres of the subject property is made up of Selle-Mission complex, 0 to 12 percent slopes (yellow) and is considered, "Prime farmland, if drained". In summary, approximately 2-acres of the 10-acre property falls under the designated categories of Prime Farmland per the Natural Resources component of the Comprehensive Plan.

Per the applicant's reconsideration request they contend that Selle-Mission Unit 50 is not prime farmland. **See Reconsideration Request.**

Served by a Network of Public/Private Roads:

Access to the site is currently provided by Hidden Valley Road, a Bonner County owned and maintained right-of-way via Highway 95, an Idaho Transportation Department owned and maintained highway. Idaho Transportation Department responded with "No Comment" and a comment was not received from the Bonner County Road and Bridge Department.

Within the Floodway:

The subject parcel is not located within a mapped floodway per FIRM Panel Number 16017C0710E, Effective date 11/18/2009.

Contain Limited Access to Public Services:

The subject parcel has access to public services. Public services that are available to this property include: North Side Fire District, Bonner County EMS & Sherriff, and Northern Lights, Inc.

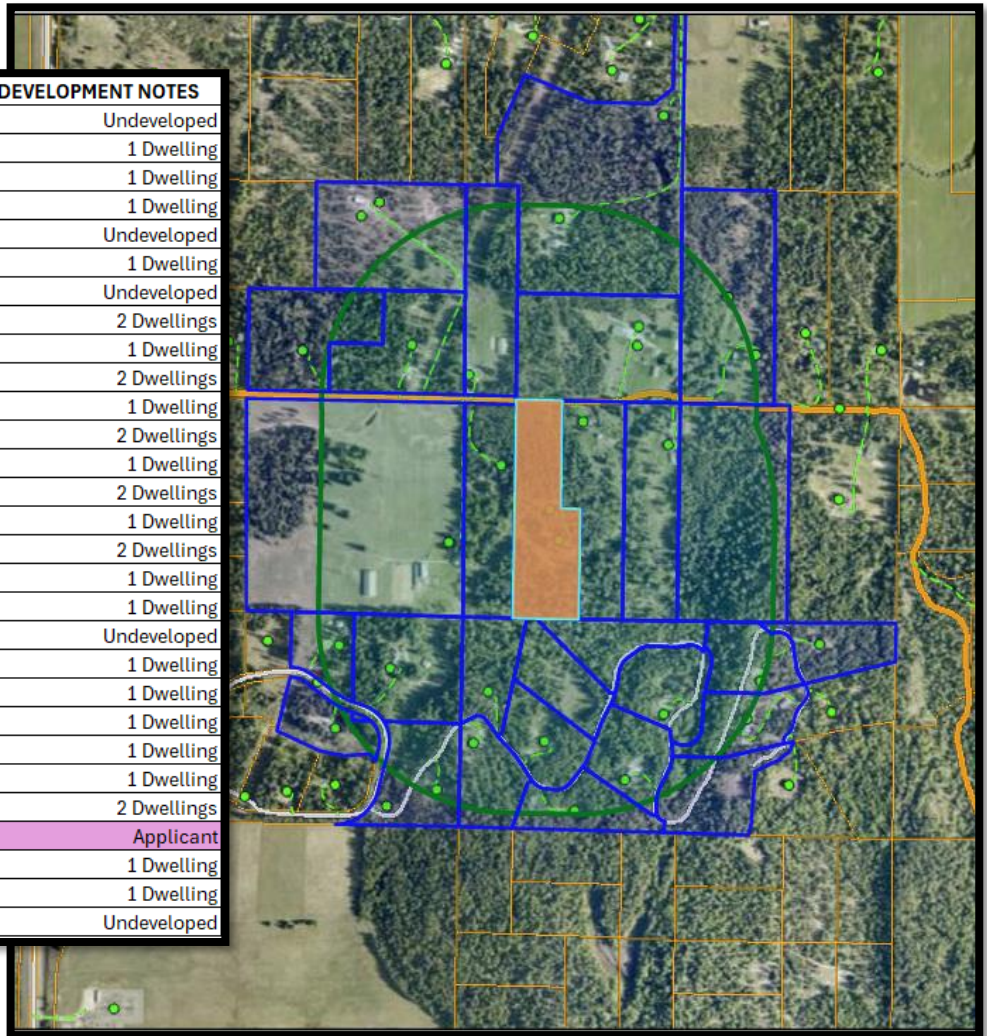
Rural 5:

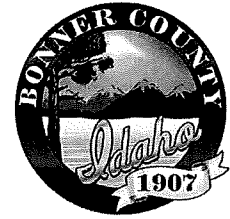

While Panhandle Health District (PHD) does not have an opinion on the proposed zone change, PHD would like to clarify some items that could potentially be an issue if/when the 10 acre parcel is split.

The applicant states, and PHD agrees, that the two existing dwellings on the subject parcel currently share a septic system and well. However, if the land were to be split, *and ownership changes*, the applicant will need to create an easement for the septic system, its replacement area, and the shared effluent line. The same will apply for the water rights as shared wells require proper documentation legally secure the water rights to both proposed lots/parties. Both of these requirements would be reviewed and/or approved through Health District Review of the plat prior to signing, as long as Bonner County requires there to be Sanitary Restrictions lifted in the event that the parcel is split into two 5-acre parcels. If Bonner County does require PHD approval on the plat, a Subdivision/Land Application must be submitted to Panhandle Health District.

Good morning,

The proposed Application specifies that water will be served using existing well D0013811 to provide water uses for two current residences which will continue following land division approval.

Idaho Department of Water Resources (IDWR) – Northern Regional Office **doesn't have any conditions of approval requirements for the proposed project** but offer the following information as education for the property owners:

- IDWR has received a Notice of Claim No. 96-10808 in the Clark Fork Pend Oreille River Basin (CFPRBA) process that contemplates diversion from the ground water well for domestic use for two homes (1 home and 1 manufactured home). The Department has not finalized evaluation and recommendations in the CFPRBA process for this Notice of Claim yet, but the filing is Active in the process.
- The existing water uses proposed by Notice of Claim 96-10808 may be covered by **Idaho Code §42-111** but the property owner is encouraged to contact Department adjudication staff upon approval and finalized rezone/land division to evaluate if amending the claim and/or adding an additional claim is recommended.
- If water use from the proposed private ground water well exceeds water uses authorized by **Idaho Code §42-111** following project completion, a new Application for Permit is required, and the property owner needs to contact IDWR to discuss water right requirements. Based on application analysis I offer the following additional information regarding **§42-111**:
 - The resulting two parcel land division is not considered a subdivision IAW **Idaho Code §50-1301(18)**.
 - The land division is not within a designated Ground Water Management Area.
 - The well is proposed to be shared at some point in the future between two parcels.
 - Domestic Exemption water use authorizes the diversion of water for homes, organizational camps, public campgrounds, or livestock so long as the **total combined use from the well is less than 13,000 gallons per day and less than a total of ½ acre combined irrigation**. So long as these requirements are not exceeded no additional water right filing is required by the landowner(s).

- Typically, combined irrigation of more than ½ acre between landowners results the need to file an Application for Permit to maintain compliance with State Statute.

Bonner County Planning Department,

While Panhandle Health District (PHD) does not have an opinion on the proposed zone change, PHD would like to clarify some items that could potentially be an issue if/when the 10 acre parcel is split.

The applicant states, and PHD agrees, that the two existing dwellings on the subject parcel currently share a septic system and well. However, if the land were to be split, *and ownership changes*, the applicant will need to create an easement for the septic system, its replacement area, and the shared effluent line. The same will apply for the water rights as shared wells require proper documentation legally secure the water rights to both proposed lots/parties. Both of these requirements would be reviewed and/or approved through Health District Review of the plat prior to signing, as long as Bonner County requires there to be Sanitary Restrictions lifted in the event that the parcel is split into two 5-acre parcels. If Bonner County does require PHD approval on the plat, a Subdivision/Land Application must be submitted to Panhandle Health District.

I respectfully appeal the Board's decision, file ZC0003-25, regarding the classification of soils and slopes on my property. The Board's findings misapplied BCRC 12-323, relied on standards not found in the ordinance, and mischaracterized the soils evidence in the record.

1. Slopes – Misapplication of Ordinance Language

BCRC 12-323(B)(1)(a) states that R-10 zoning is appropriate for parcels:

“Characterized by slopes that are steeper than thirty percent (30%).”

The Board's findings, however, concluded that R-10 applies due to the “**presence of 30+% slopes on the property.**”

The Board found that the parcel does not meet the requirements for the Rural 5 zoning district due to the presence of prime agricultural soils and slopes. The Board found that the parcel more closely fits Rural 10 description.

This is a fundamental error. The ordinance does not use the word “presence”, or “contains”, It uses “characterized by,” which has a materially different meaning.

According to Merriam-Webster, to “characterize” means “to describe the distinguishing trait or quality of; to be a constituting feature of.” A parcel is “characterized by” steep slopes only if such slopes are the defining or predominant trait.

On this property, approximately 1 acre out of 10 (approximately 10%) may exceed 30% slope. The overwhelming majority of the parcel consists of gentle slopes (0–12%). It is not accurate to say the parcel is “characterized by” steep slopes.

By substituting “presence” for “characterized by,” the Board effectively rewrote the ordinance. Under such a standard, virtually any parcel with even a small pocket of steep ground would be forced into R-10, collapsing the distinction between R-5 and R-10. Idaho law and precedents do not permit agencies to alter ordinance language through interpretation.

A similar, recent file, is Bonner County ZC0007-24 which also determined that the slopes on the property did not reach the threshold of “Characterized by slopes that are steeper than thirty percent (30%)” even though slopes in excess of 30% were present, it was not the distinguishing trait and approved the file.

Bonner County itself recognizes that generalized mapping products cannot be treated as determinative without field verification. For example, when land is proposed for development and the USFWS wetlands mapper shows possible wetlands, the County through BCRC, requires a formal wetland delineation before approving development. The wetlands mapper carries disclaimers that it is not a precise delineation, and the County properly requires verification.

However, no such requirement exists in the Bonner County Revised Code for soils. There is no provision requiring a soil survey or field investigation to confirm NRCS map classifications before they are used in zone changes or development decisions.

Requiring one in this instance, is not substantiated in BCRC.

2. Geotechnical Ordinance Already Protects Against Slope Hazards

After 12-323 was adopted in 2008, the County addressed health and safety concerns on steep slopes through BCRC 12-762: Geotechnical Analysis Required (Ord. 590, 2019; Ord. 661, 2022). That ordinance requires that any proposed development on slopes $\geq 30\%$ undergo a geotechnical analysis prepared by a licensed Idaho engineer. The study must evaluate slope stability, hydrology, erosion hazards, and prescribe mitigation measures.

This ordinance provides the necessary check-and-balance to ensure safe development on steep slopes. Thus, it is unnecessary — and improper — to stretch BCRC 12-323 to force parcels into R-10 based merely on the presence of minor steep areas. Public health, safety and environmental concerns are already secured through the geotechnical requirement.

3. Soils – Selle–Mission Unit 50 Is Not Prime

BCRC 12-323(B)(1)(c) requires that R-10 apply only to parcels that “contain prime agricultural soils.” The evidence does not support the conclusion that my property meets this requirement.

2005 Natural Resource Component: At the time Ordinance 12-323 was adopted in 2008, the County’s Comprehensive Plan included the 2005 soils inventory. That document explicitly classified Selle–Mission complex (map unit 50, 0–12% slopes) as Non-Prime.

This is further evidenced by the language found in the 2005 Comp Plan, “About 65,565 acres, ... of the soil survey area meets the soil requirements for prime farmland.” The 65,565 acre figure is the culmination of the listed Prime soil units listed in the document.

2022 Natural Resource Component: The most recent update confirms the same:

Table 7 (Prime Farmland, 2022): lists $\approx 65,515$ acres of “All areas prime farmland.” Selle-mission complex soil map unit 50 is not included.

Both inventories show consistency over time: Bonner County has approximately 65,500 acres of prime soils, and Selle-Mission complex unit 50 has never been included in that total.

NRCS Disclaimer: NRCS itself cautions:

“The soil boundaries are general and soil delineations are approximate. For site-specific projects, an onsite investigation is required.” (NRCS Web Soil Survey disclaimer)

4. Conclusion

The Board’s findings are not supported by the ordinance or the record:

On slopes, the ordinance requires parcels to be “characterized by” steep slopes. The Board improperly applied a different standard of “presence.” The parcel is not characterized by steep slopes.

On soils, both the 2005 and 2022 inventories confirm that Selle–Mission complex unit 50 is not prime farmland. It has never been included in the County’s ≈65,500 acres of prime soils. At most, it is conditionally “prime if drained,” which does not satisfy ordinance requirements.

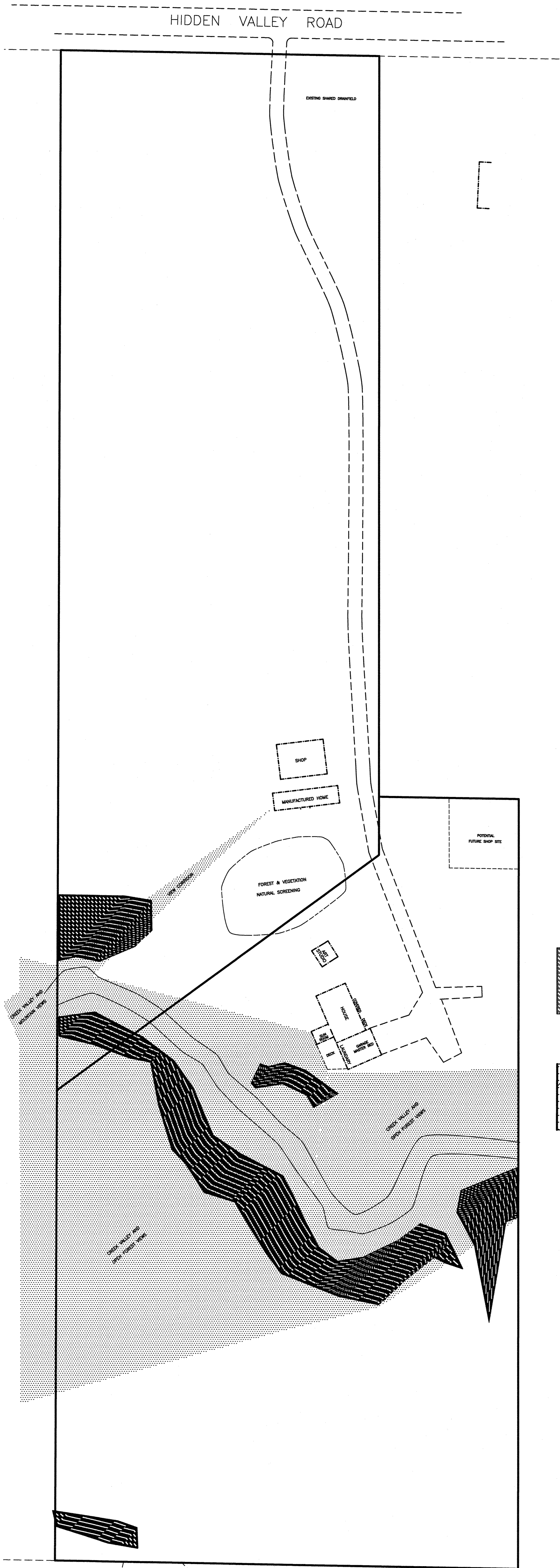
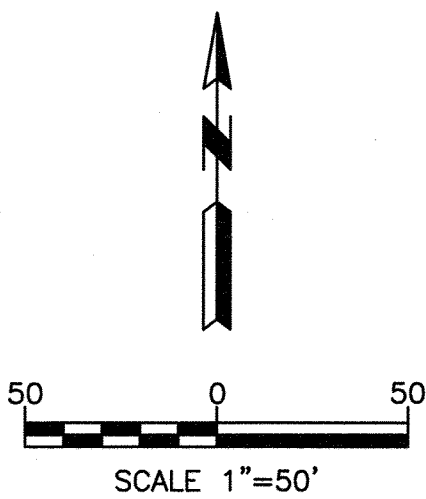
The decision misapplies the law, misrepresents the record, and should be reconsidered.

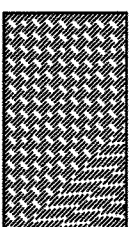

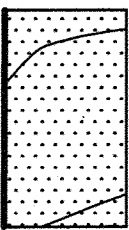
DEVELOPER'S NOTE

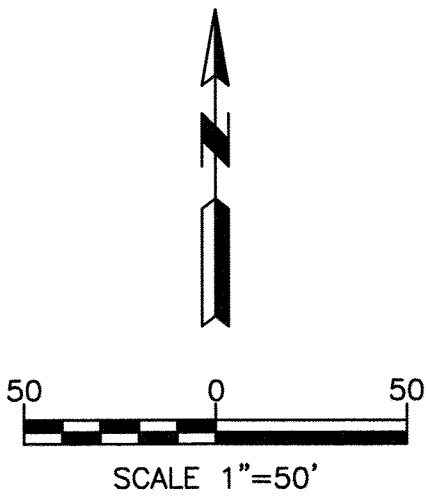
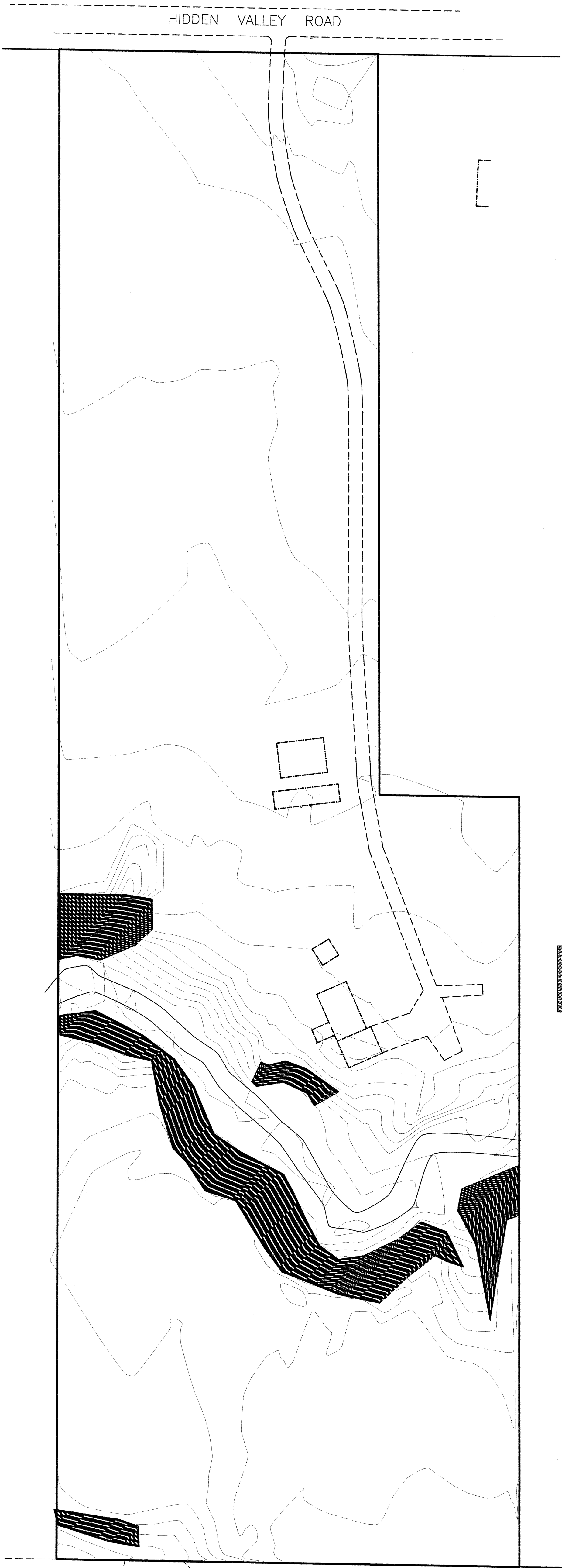


VIEW CORRIDORS FOR EXISTING BUILDINGS

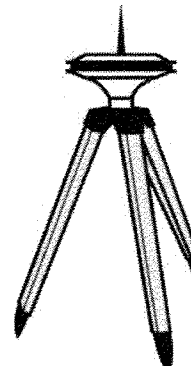
