File V0021-26 – Variance – Property Line Setback: Request for a street setback Variance of 10-feet, where 25 feet is required, for a single-family dwelling. The 0.322-acre parcel is zoned Recreation and located off South Idaho Club Drive and Timber Grove Lane in Section 2, Township 57 North, Range 1 West, Boise-Meridian.

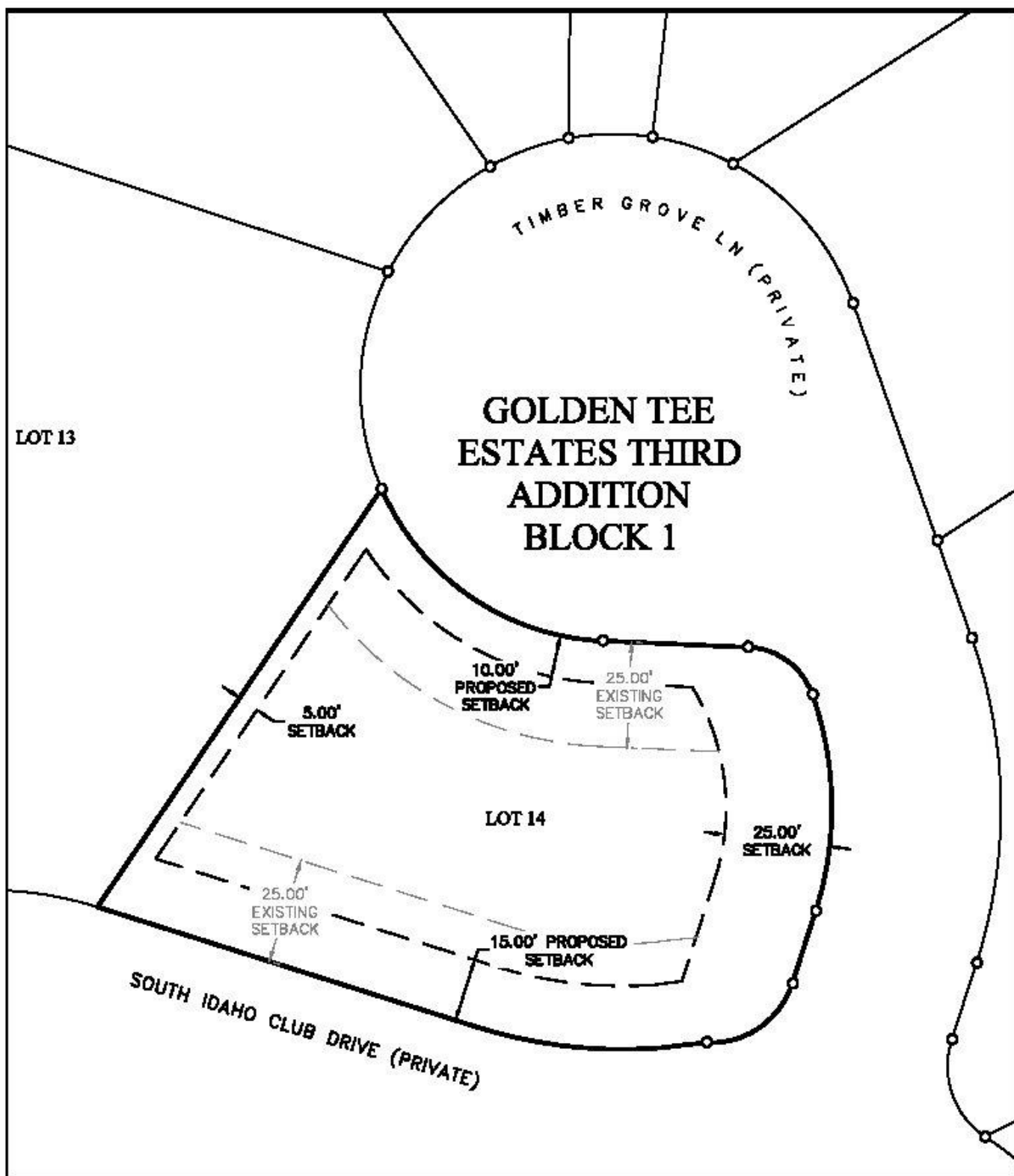

The referenced start time stated above reflects the beginning of the hearing. Specific file start time and hearing duration vary.

During the hearing for this application, the public will be given an opportunity to provide testimony and/or evidence regarding how the proposal does or does not comply with the applicable approval criteria of the Bonner County Revised Code. At the close of the public hearing, the governing body will make a decision on the application that may include, but is not limited to, approval, denial, remand, or continuance of the public hearing.
