<u>File V0002-20 – Waterfront Setback Variance – Bryan Flaig</u> is requesting a 26-foot waterfront setback where 40-feet is required to allow for the construction of a canopy over an existing desk that was built in 1975. The property is zoned Rural-5. The project is located off W. Lakeview Blvd in Elders Lakeview Lots, Block 3, Lots 12 & 13, in a portion of Section 29, Township 56 North, Range 5 West, Boise-Meridian.
