## SAGLE NEIGHBORHOOD COMMITTEE MEETING MINUTES THURSDAY, MAY 9, 2019

**CALL TO ORDER:** Chair Gunter called the Sagle Neighborhood Committee meeting to order at 6:00 p.m. on Thursday, May 9, 2019 in the Bonner County Multi Use Facility on Hwy 95, Sagle, Idaho.

**APPROVAL OF MINUTES:** The Chair requested the committee declare if they had any corrections or changes to the approval of minutes as written for: April 11, 2019. S. Joe Wilson moved to approve minutes. Fred Arn seconded the motion. Voted upon and the motion passed.

## **GROUP DISCUSSION:**

Presentation from the school transportation district made by James Koehler.

He gave a summary of the bus routes for the Sagle area. He stated as a general rule they try to "hub stop", as door-to-door is almost impossible. He spoke about policies. He spoke about requirements for stops ie. turnarounds, etc. He stated as a rule of thumb they try to never require a bus to have to backup. He stated there are approximately 450 children that ride the bus. He stated there are safety busing zones in place within a mile and half from the schools that allow for bus riders within this radius. He stated that a special needs route requires door-to-door service. In response to a question from Fred Arn, he stated a standard added to new subdivisions might be a good idea to facilitate in determining if a route change may be needed. He stated there are no stops on private roads. He stated two stops need to be fixed. One is at Tower Road and the other is on Falcon Way. He further stated making a left hand turn on Sagle road is going to be difficult once the new highway goes in. He stated, in response to a question from Mark Linscott, development in the Sagle area will not cause an adverse fiscal impact to the school district. Another problem area is Lakeshore at the bridge.

The group discussed the School Facilities and Transportation element. They worked on the language for the Objective, Goals and Policies.

Fred Arn moved to adopt the County Comp Plan Chapter 3 Objectives and Policies page 12 changing the word County to Sagle. S. Joe Wilson seconded the motion. Voted upon and the motion passed.

Fred Arn asked staff if they can get someone to come in and talk about the viability of evaporative ponds.

Homework for the next meeting:

Amanda will update the new language voted on at this meeting and will send it to the committee.

Read the printed Economic Development handout for discussion at the next meeting.

Review the Idaho Workforce Trends handout for discussion.

Staff will get data relating to ADU for the last two years to present at the next meeting.

Fred Arn moved to adjourn the meeting. Jim Kelly seconded the motion. Voted upon and the motion passed.
