REQUEST FOR METAL WASTE DISPOSAL

The Bonner County Solid Waste Department seeks a statement of proposal, qualification and price per ton, to be paid to Bonner County, for baling, and proper disposal of the metal piles at the locations listed below.

1. Purpose:
Bale, transport and properly dispose of the metal piles located at the Colburn Transfer Station (Sandpoint), the Idaho Hill Transfer Station (Oldtown) and the Dickensheet Transfer Station (Priest Lake)
2. Equipment and Labor:
 - a. Contractor to provide:
 - All necessary baling, loading and transportation equipment
 - All necessary labor to complete the operation in the timeframe required
 - Transportation and disposal of metal in compliance with all applicable laws and regulations
 - Any permits or certifications needed to perform the work
 - Payment to Bonner County after each site is completed
 - Report of quantity of debris removed at each location
 - b. Contractor Requirements:
 - Submit prior experience information
 - Proof of worker's compensation insurance
 - Proof of liability insurance in the amount of \$1,000,000.00 per occurrence and \$2,000,000.00 annual aggregate
 - Must name Bonner County as also insured
 - \$3,000.00 performance bond to be submitted upon award
3. Work to be performed:
 - a. Contractor shall be responsible for the baling and removal of the three metal piles
 - b. Work is to be performed and completed by September 30, 2026.
 - c. Contractor shall keep appropriate logs of work performed as to the quantity of debris baled
 - d. Hours of operation shall be 7:00 a.m. to 5:00 p.m., Monday through Saturday
 - e. After the baling is completed, the contractor shall clear and remove any debris that was unable to be baled
4. Length of contract/funding
 - a. The contract will be for the current fiscal year ending on September 30, 2026

- c. Bidders can determine the total number of tons by visiting each of the three sites

Submit to Bonner County your proposal, qualification and the price per ton to be paid to Bonner County for the baling of the metal at the three locations identified above. Include all of the required information listed above.

The Board of Commissioners reserves the right to reject any and all proposals, to revise or to waive formalities which do not affect the essential fairness of the bidding process and to review the proposals to determine which is best for Bonner County overall.

All statements of proposals and quotes must be returned to Bonner County Board of Commissioners, 1500 Highway 2, Suite 308, Sandpoint, ID 83864, by 5:00 p.m. (prevailing local time) on Monday, September 22, 2025. Bids will be opened by the Bonner County Board of Commissioners at 1:00 p.m. on Tuesday, September 23, 2025.

The statements and prices will be reviewed and ranked by Bonner County Solid Waste personnel. The bids will be screened and ranked by the statements and prices paid to Bonner County per ton, based on the criteria described above. The selection team reserves the right to conduct interviews of the bidders or to make a decision directly from the proposals.
