WHEREAS, it is the wish of the Board to utilize said provision to show appreciation to Detention Deputy Debra Baker for her dedication and service to Bonner County

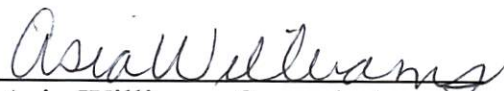
