WHEREAS, Idaho Code 31-1605 provides that the Board of County Commissioners may adjust the budget as adopted, provided that there shall be no increase in anticipated property taxes; and,

WHEREAS, the Bonner County Sheriff's Office has positions currently not filled in the "A" Budget, allowing for an overage, and;


WHEREAS, this overage can be used to cover our unanticipated costs due to non-budgeted projects and help reduce expenses to next year's budget, including: Office supplies, ink/toner, patrol uniforms/equipment, (4) Mobile Data Computers, (10) Computers, and (1) Drone.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Bonner County authorizes the Clerk to open the Sheriff's Office "B" budget and increase line item 03450-8590 Admin - Equipment by \$25,000.00; 03451-6530 Clerical - Office Supplies by \$2,000.00; 03453-8590 Patrol - Equipment by \$28,000.00; 03454-8590 Search & Rescue - Equipment by \$5,000.00 and reduce line 03472-6020 by \$60,000.00.

ADOPTED as a Resolution of the Board of Commissioners of Bonner County upon a majority vote on the 28th day of August, 2018.


