WHEREAS, the Board of Commissioners wish to authorize the expenditure of those funds to the Bonner County Emergency Management for hazard fuel reduction projects; and

WHEREAS, according to the Secure Rural Schools (SRS) Act, Title III County Funds shall be used as follows:

- (1) To carry out activities under the Firewise Communities program to provide to homeowners in fire-sensitive ecosystems education and assistance to implement techniques such as in-home siting, home construction, and home landscaping that can increase the protection of people and property from wildfires;
- (2) To reimburse the participating county for search and rescue and other emergency services, including firefighting and law enforcement patrols, that are:
 - A. Performed on Federal land after the date on which the use was approved under subsection (b);
 - B. Paid for by the participating county; and
- (3) To cover training costs and equipment purchases directly related to the emergency service described in paragraph (2); and
- (4) To develop and carry out community wildfire protection plans in coordination with the Bureau of Land Management (BLM) acting on behalf of the Secretary of Interior.

NOW, THEREFORE, BE IT RESOLVED, that the Board of County Commissioners hereby authorize the expenditure of SRS Title III Funds in the amount of \$43,943.48 to the Bonner County Emergency Management for hazard fuel reduction projects.
