

### Memorandum

Re: Appointment of Commissioners to Planning Commission

The terms for two Planning & Zoning Commission members expire September 30, 2017. Commissioner Sheryl Reeve has submitted her name for consideration for reappointment to a first full three-year term on the Planning Commission. Commissioner Kris Sabo has advised she will not be seeking reappointment.

Attached is a proposed resolution re-appointing Sheryl Reeve and Matt Linscott to a three-year term on the Planning Commission. State code (I.C. 67-6504) requires the Board Chairman to submit the name of the candidate for appointment, and for the majority of the Board to confirm the appointment. The Board chair advised October 4, 2018 that he is interested in submitting Sheryl Reeve's name for reappointment and Matt Linscott's name for appointment to the Planning Commission.

Commissioner Reeve represents Commissioner District #2. Commissioner Linscott represents Commissioner District #1. These two positions were advertised in the paper and on social media. There were several letters of interest received.
